2. Schedules of Controlled Substances: Rescheduling of Marijuana

- The Department of Justice ("DOJ") proposes to transfer marijuana from Schedule I of the Controlled Substances Act ("CSA") to Schedule III of the CSA. The DOJ is soliciting comments on this proposal. All comments must be **submitted by July 22**.

- The Michigan Suicide Prevention Plan for 2024-2027: A Systems Level Approach to Preventing Suicide has been released. This plan helps to provide a public health approach to addressing the rise in suicide rates affecting our communities.
